<u>PURPOSE</u>

To provide the Board of Education with a list of public gifts given to the St. Vrain Valley School District for the fourth quarter of the 2023-2024 school year totaling \$305,230.95. The total of all the gifts given to the District for the 2023-2024 school year is \$1,020,022.34.

BACKGROUND

During the course of the year, the District receives many cash and gift donations for its programs. RECOMMENDATION

That the Board of Education approve the selection of BC Interiors and authorize the Procurement staff to negotiate and finalize an FF&E agreement for the Rose Building project, with a not-to-exceed amount of \$225,000.

BACKGROUND

The Procurement Department has established a pre-qualified list of skilled, professional and dedicated educational furniture suppliers to provide furniture, fixtures and equipment (FF&E), who through direct contracting arrangements, can meet a majority of furniture requirements for the district's projects.

In consideration of furniture lead times and the anticipated project schedule, the district selected two vendors from the pre-qualified list to present proposals for the Rose Building project. Both suppliers prepared proposals and participated in a presentation session with a review committee. Based on this process, the district has chosen BC Interiors for their experience, internal resources available to provide the required products, ability to meet delivery and installation deadlines, and most advantageous pricing proposal.

RECOMMENDATION

That the Board of Education approve the Sale of Surplus Technology Products (iPads) and Services to Cal State Electronics, Inc., DBA: Total Technology, for an estimated sale amount of \$3,673,040.

BACKGROUND

The Purchasing Department issued Request for Proposal #2025-002 on June 26, 2024, to five (5) vendors who are pre-qualified by the district for the purchase of surplus technology products (RFQ #2024-041). Four (4) responses were received on Thursday, July 11, 2024. All responses were reviewed for minimum submittal requirements and then evaluated based on price and payment schedules offered, technical response to the requested scope of services and overall quality of the proposal. As a result of this extensive process, it was determined that Cal State Electronics, Inc., DBA: Total Technology, offered the highest return for the district iPad refresh and scored the highest in the other criteria as evaluated by committee.

The minimum estimated revenue to the District for the collection of 28,000 iPads is \$3,673,040. This revenue may be higher depending on the number of iPads able to be returned before October 1, 2024 and if the estimated number of damaged iPads returned (which are valued at a lower price than functional iPads) are less in number than projected.
